REVENUE DEPARTMENT, GOVT. OF NCT OF DELHI **GUIDELINES FOR ENROLMENT AS CIVIL DEFENCE VOLUNTEER**

Eligibility Criteria

The applicant is entitled for the enrolment as Civil Defence Volunteer if

- He/she is a resident of Delhi:
- Has completed the age of 18 years provided that this age limit may be relaxed in the discretion of the competent authority up to a maximum of 3 years for any branch or category of the Corps:
- Has passed at least the primary standard i.e. till the fourth class and this condition may be relaxed by the controller in his discretion.
- Both men and women shall be eligible for appointment to the Corps.
- NOC from the Employer is required if the applicant is in employment.
- A person shall not be entitled to be enrolled to the corps unless he is found to be physically fit and mentally alert.
- Members of the following forces or services are not ordinarily eligible for enrolment in civil defence corps:
 - a. Armed Forces of the Union.
 - b. Police Force:
 - c. Fire Services:
 - d. Territorial army or Auxiliary Forces of any of the Defence services;
 - e. Civilian personnel employed in connection with the Armed Forces of the Union.
- The above regulation shall not apply to Government servants who are specifically deputed for whole time or part time civil defence duties by the heads of organization or services concerned.

 - should be in a plain white or off-white background
 - should have a natural expression (closed mouth)
- should be of full head from top of hair to shoulder
- shouldn't be shadows on the face or background
- should not include sunglasses or hats

Important Note

- Self-attested copy of the original documents to be produced while applying at Citizen Service Centre (CSC) and if applying online then documents are to be uploaded in e-District application software. Physical verification of some documents may be necessary at the counter even in case of online application.
- The Applicant himself/herself /any of his family members should be present at the CSC for photograph or to submit his/her photograph. In case of online application, applicant must upload his/her photograph (As per above specifications)
- Scanned copy of Self- Declaration has to be uploaded while applying online and hard copy of declaration has to be submitted to the concerned SDM/Tehsildar/CSC by hand or speed post/registered post along with Application /Acknowledgement number.
