On 29 Jul 05, [REDACTED] Desk Sergeant, 939<sup>th</sup> Military Police (MP) Company (Co), Camp Victory, Baghdad, IZ, reported there was a fatal traffic accident involving a commercial crane vehicle and a US Military M1078 A1 Light Medium Tactical Vehicle (LMTV).

Investigation established Mr KAYIM died as a result of a traffic accident, when the LMTV, operated by [REDACTED] Headquarters and Headquarters Company (HHC), 612<sup>th</sup> Engineer Battalion (Bn), CLIZ, left the roadway, overcorrected and struck Mr KAYIM's vehicle, head-on.
