## BRESCIA UNIVERSITY ALUMNI UNDERGRADUATE TUITION DISCOUNT POLICY

An alumnus of a Brescia undergraduate program is eligible for a 25% tuition discount on Brescia's undergraduate courses. An alumnus of a Brescia undergraduate program is any individual who has earned a B.A., B.S., or B.S.W. from Brescia.

Brescia alumni who are currently receiving Brescia grants or scholarships including but not limited to academic or athletic scholarships, are not eligible for the 25% alumni tuition discount.

A child of an alumnus who is 25 years old or younger, the spouse of alumnus, or the dependent of an alumnus as defined by the Internal Revenue Code is eligible for a 10% discount on Brescia's undergraduate courses. This 10% discount applies to a child, spouse or dependent of an alumnus of a Brescia undergraduate program or graduate program.

A Free Application of Federal Student Aid (FAFSA) must be completed each academic year to receive the tuition discount. The discount will not be applied if the FAFSA is not completed.

Alumni Tuition Discount Application must be completed and submitted to the Financial Aid office by the <u>first day of classes</u>. The Alumni Undergraduate Tuition Discount Application must be completed each academic year.

Alumni Tuition Discounts do not apply to discounted tuition rates including but not limited to audited classes, intersession classes, summer classes, online degree completion programs, STARS programs, and graduate programs.

The Director of Alumni Relations will verify eligibility. The Financial Aid Office will verify completion of FAFSA. The Vice President of Business & Finance and the Vice President of Institutional Advancement will decide questions of eligibility.
