All memberships are subject to approval of Windward Lake Club. Membership does not confer or include any ownership, beneficial or vested interest in the Facilities, assets of Windward Lake Club, or the Club Facilities or activities. Membership is not transferable. Initiation fees and dues are non-refundable and subject to change. Membership in Windward Lake Club and the use of the Facilities are subject to reasonable rules and regulations and are subject to amendment from time to time. Windward Lake Club reserves the right to terminate a membership, if a member is deemed to be in violation of any rules, regulations, code of conduct, or otherwise stated policies.

Failure of the Windward Lake Club to enforce any of the General Rules & Regulations of said Club or any conditions or right under the Membership Application shall not be deemed or construed to be a waiver by the Windward Lake Club of said General Rules & Regulations, conditions or rights.

All Full Facility & Tennis membership dues are payable monthly and are due upon receipt, while Swim and Marina/Land Rack dues are payable annually and also due upon receipt. Dues are collected by invoice or charged to an approved credit card (Visa, MasterCard, and Discover only). Any bills not paid within 15 days of the due date may be subject to a 10% late fee. If a member's account exceeds 60 days overdue, membership privileges will be suspended. Any Member whose account remains unpaid 90 days after the due date will have their membership automatically terminated in poor standing.

RESIGNATION POLICY: Membership in the Club is continuous, but may be terminated at any time, by the member, if written notice is given 30 days in advance of the desired termination date. To terminate your membership in good standing, the Member is required to provide written notice via a Membership Change Form and bring any account balances to zero.

All exercise and participation is done at the risk of the Member and his/her Guest. Windward Lake Club is not liable for personal injury, theft, loss or damage of personal property.
