

SERVICE CONTRACT AND AGREEMENT

This form is the sole property of Seasonal Lawncare and it should not be copied, duplicated, or adapted in any manner. Alterations or any changes cannot be made, except A-6 below.

SECTION A. TERMS AND CONDITIONS: For your Multi-Year Contract and Amendments.

1) How to begin the Seasonal Lawncare Program.

Please fill out all the information below, sign, and return via fax to (716) 675-1942.

2) Program, Payment and terms.

Your lawn service will start with our Six Step Recommended Treatment Program (unless other programs are specified below). An invoice will be left after each treatment for your prompt remittance (payment due upon receipt of invoice), or pay online at SeasonalLawncare.com.

3) Late Payment and Fees.

Invoices are due upon receipt, and are past due after 21 days. Rescheduling fees are charged monthly. Seasonal Lawncare reserves the right after 90 days to cancel services at any time and void all guarantees because of late payments. A \$30.00 service charge will be assessed on any returned checks and refunds. Service will not continue until balances are paid in full.

4) 5% Pre-Payment (Volume Discount).

We will mail this information to you within three days. If you choose to pre-pay for your year's service, you will receive a 5% Volume Discount. Pre-payment is not required to begin service.

5) Guarantee.

Many variables can affect your landscape; site

conditions, weather, environmental stress, mowing, etc. and we obviously can't guarantee what we cannot control. **BUT WE CAN, AND DO GUARANTEE OUR SERVICE.** If you are not satisfied with the results of an application, notify Seasonal Lawncare within 10 days. We will retreat the problem area free of charge. We can, at times make special recommendations to rectify any further problems from recurring (full service customers only). Our goal is complete customer satisfaction.

6) Multi-Year Contract Amendment, Annual Renewal Updates.

This is a multi-year contract; we will continue to maintain your lawn in future years as defined in Exhibit A., B. and C. Each spring you will receive a new Multi-Year Contract Amendment and renewal information. This will include treatment dates (including years), pricing per treatment updates, total yearly cost, product updates, new labels and special offers. By signing below you agree to receive an annual contract amendment update each spring.

7) How to Discontinue Service

You may discontinue service at any time by providing us with a written notice 48 hours in advance of any scheduled treatments and without penalty. Previous balances will still be due.


