APPLICATION FOR PLUMBING SPECIALTY APPRENTICE REGISTRATION

A person wishing to be become a specialty apprentice shall register with the Division of Building Safety (DBS) prior to going to work and complete the requirements for that specialty classification in order to test for specialty journeyman. A specialty apprentice shall be any person who is engaged in learning and assisting in the specialty classification for which they are registered. Specialty apprentices shall not perform specialty work except under the supervision of a specialty journeyman.

EXPERIENCE GAINED BY AN INDIVIDUAL WHILE ENGAGED IN THE PRACTICE OF A SPECIALTY CATEGORY <u>SHALL NOT BE</u> CONSIDERED TOWARDS THE SATISFACTION OF THE MINIMUM EXPERIENCE REQUIREMENTS FOR LICENSING AS A JOURNEYMAN PLUMBER.

APPLIANCE PLUMBING SPECIALTY LICENSE REQUIREMENTS

Appliance plumbing specialty journeymen must have eighteen (18) months of specialty apprentice on-the-job experience, satisfactory completion of seventy-two (72) hours of approved related training classes (see back page of application for schooling information) in order to be approved to take the specialty appliance journeyman exam. Appliance plumbing specialty apprentices must be employed by a licensed contractor, under the supervision of a journeyman, be enrolled in or have completed approved related training classes, and maintain state registration.

WATER PUMP PLUMBING SPECIALTY LICENSE REQUIREMENTS

Water pump specialty journeymen must have eighteen (18) months apprentice on-the-job experience, satisfactory completion of twelve (12) hours of approved related training classes, (see back page of application for schooling information) in order to be approved to take the specialty water pump journeyman exam. Water pump plumbing specialty apprentices must be employed by a licensed contractor, under the supervision of a journeyman, be enrolled in or have completed approved related training classes, and maintain state registration.

Registration for a specialty apprentice shall expire three (3) years from the month of issue unless renewed. A specialty apprentice registration may be renewed at any time during the month prior to its expiration. Failure of any apprentice to timely renew a registration shall cause a lapse of the registration. <u>Time shall not be</u> credited while the apprentice is inactive or not registered.

APPLICATIONS WILL NOT BE PROCESSED UNLESS COMPLETELY FILLED OUT, SIGNED, NOTARIZED, AND ACCOMPANIED BY THE \$30 REGISTRATION FEE. Payment may be made in the form of personal check, money order, or cashier's check. All applications paid for with a check will be held an additional 10 business days to allow the check to clear.
