A BILL

To amend title 49, United States Code, to require gas pipeline facilities to accelerate the repair, rehabilitation, and replacement of high-risk pipelines used in commerce, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Pipeline Modernization
- 5 and Consumer Protection Act".

1	SEC. 2. REPLACEMENT PROGRAMS FOR HIGH-RISK NAT-
2	URAL GAS PIPELINES.
3	(a) FINDINGS.—Congress finds that—
4	(1) Federal requirements related to repairing
5	pipeline leaks are limited to "hazardous" leaks,
6	which are leaks that represent an existing or prob-
7	able hazard to persons or property and require im-
8	mediate repair;
9	(2) there are no Federal requirements to ad-
10	dress slower or less hazardous leaks, which can allow
11	the leaks to persist unrepaired indefinitely;
12	(3) in States without a standard definition and
13	methodology for calculating unaccounted-for gas (the
14	difference between the amount of gas purchased by
15	a utility and the amount used or sold to customers),
16	data inconsistencies may be pervasive and these in-
17	consistencies hinder the ability of regulators to mon-
18	itor gas system and utility performance;
19	(4) the cost of leaked or otherwise unaccounted-
20	for natural gas in the distribution system is typically
21	passed on to ratepayers without limitation as an ac-
22	cepted cost of service, which removes financial incen-
23	tive for utilities to minimize the leaks;
24	(5) methane, the primary constituent of natural
25	gas, is a greenhouse gas at least 20 times more po-

gas, is a greenhouse gas at least 20 times more potent than carbon dioxide;

- 1 (6) according to the Pipeline and Hazardous
 2 Materials Safety Administration, the United States
 3 natural gas distribution system still includes 61,000
 4 miles of bare steel pipe without adequate corrosion
 5 protection and 32,000 miles of cast iron pipe, which
 6 was installed beginning in the 1830s and can be
 7 prone to failure;
 - (7) major recent pipeline explosions that led to human fatalities, including those in Austin, Texas, Philadelphia, Pennsylvania, and Allentown, Pennsylvania, have been traced to aging, leaking, and highrisk pipeline infrastructure;
 - (8) natural gas distribution utilities may be discouraged from making capital expenditures for the replacement of leaking and failure-prone pipelines because traditional ratemaking structures may not allow for cost recovery on a timely basis; and
 - (9) according to the Pipeline and Hazardous Materials Safety Administration, the natural gas pipeline replacement programs established as part of the ratemaking process in 27 States and the District of Columbia have played a vital role in enhancing public safety by better ensuring the prompt rehabilitation, repair, or replacement of high-risk natural gas distribution infrastructure.

1	(b) Natural Gas Distribution Companies.—
2	(1) In General.—Chapter 601 of title 49,
3	United States Code, is amended by inserting after
4	section 60112 the following:
5	"§ 60112A. Replacement programs for high-risk nat-
6	ural gas pipelines
7	"(a) Definition of Gas Pipeline Facility.—In
8	this section, the term 'gas pipeline facility' includes—
9	"(1) a distribution facility; and
10	"(2) a gas utility.
11	"(b) In General.—Each operator of a gas pipeline
12	facility shall, in accordance with an integrity management
13	program required under section 60109 of this title, if ap-
14	plicable, accelerate the repair, rehabilitation, and replace-
15	ment of gas piping or equipment that—
16	"(1) is leaking; or
17	"(2) may pose high risks of leaking, or may no
18	longer be fit for service, because of—
19	"(A) inferior materials;
20	"(B) poor construction practices;
21	"(C) lack of maintenance; or
22	"(D) age.
23	"(c) Policy Options.—

1	"(1) In General.—In complying with sub-
2	section (b), each State regulatory authority and each
3	nonregulated gas utility shall consider—
4	"(A) developing prioritized timelines to re-
5	pair all leaks based on the severity of the leak,
6	including non-hazardous leaks, or replace iden-
7	tified leaking or high-risk piping or equipment,
8	including leaks identified as part of an integrity
9	management plan developed under section
10	192.1007 of title 49, Code of Federal Regula-
11	tions, if applicable;
12	"(B) adopting a cost-recovery program
13	that includes—
14	"(i) replacement plans with targets
15	and benchmarks for leaking or high-risk
16	infrastructure replacement;
17	"(ii) consideration of the economic,
18	safety, and environmental benefits of re-
19	duced gas leakage, including consideration
20	of reduced operation and maintenance
21	costs and reduced costs attributable to lost
22	or unaccounted-for natural gas; and
23	"(iii) reporting on the reductions in
24	lost or unaccounted-for gas as a result of
25	pipeline replacements;

1	"(C) adopting a standard definition and
2	methodology for calculating and reporting unac-
3	counted-for gas to improve data quality;

- "(D) adopting limits on cost recovery for lost and unaccounted-for gas; and
- 6 "(E) requiring use of best available tech-7 nology to detect gas leaks.".
- 8 (2) TECHNICAL AND CONFORMING AMEND-9 MENT.—The table of sections for chapter 601 of 10 title 49, United States Code, is amended by insert-11 ing after the item relating to section 60112 the fol-12 lowing:

"60112A. Replacement programs for high-risk natural gas pipelines.".

- 13 (c) Non-Binding Guidelines for Identifying 14 and Classifying High-Risk Pipeline Infrastruc-15 ture.—
- 16 (1) IN GENERAL.—Not later than 1 year after 17 the date of enactment of this Act, the Administrator 18 of the Pipeline and Hazardous Materials Safety Ad-19 ministration shall, after consultation with State reg-20 ulatory authorities, the Secretary of Energy, the Ad-21 ministrator of the Environmental Protection Agency, 22 the Federal Energy Regulatory Commission, and 23 other appropriate Federal agencies, and after notice 24 and opportunity for comment, issue non-binding 25 guidelines identifying best practices under section

- 3 (2) Preserving the integrity of actions ALREADY TAKEN BY STATE REGULATORY AUTHORI-TIES.—In formulating guidelines under paragraph 5 6 (1), the Administrator of the Pipeline and Haz-7 ardous Materials Safety Administration shall, to the 8 extent practicable, preserve the integrity of, and be 9 guided by, actions already taken by State regulatory 10 authorities to ensure proper identification, classifica-11 tion, and timely repair of high-risk pipeline infra-12 structure and leaks, including actions taken after 13 consideration ofthe standard under section 14 303(b)(6) of the Public Utility Regulatory Policies 15 Act of 1978 (15 U.S.C. 3203(b)(6)).
 - (3) REVISION OF GUIDELINES.—Not less frequently than once every 7 years, the Administrator of the Pipeline and Hazardous Materials Safety Administration shall review and, as appropriate, revise the guidelines issued under paragraph (1) to reflect changes in the composition and safety performance of the pipeline infrastructure in the United States.

23 SEC. 3. DATA STANDARDIZATION.

24 (a) IN GENERAL.—Notwithstanding any other provi-25 sion of law, not later than 1 year after the date of enact-

- 1 ment of this Act, the Administrator of the Pipeline and
- 2 Hazardous Materials Safety Administration and the heads
- 3 of other applicable Federal agencies shall, in consultation
- 4 with State and local agencies under subsection (c), work
- 5 jointly to establish and publish forms that adopt a stand-
- 6 ard definition and methodology for calculating and report-
- 7 ing unaccounted-for gas, including, when possible, infor-
- 8 mation on the causes of unaccounted-for gas and the
- 9 quantities associated with each cause, for use by applicable
- 10 Federal agencies to standardize the data collected on un-
- 11 accounted-for gas.
- 12 (b) Administration.—In carrying out this section,
- 13 the Administrator of the Pipeline and Hazardous Mate-
- 14 rials Safety Administration and the heads of other applica-
- 15 ble Federal agencies may—
- 16 (1) establish an interagency working group; and
- 17 (2) enter into a memorandum of understanding.
- 18 (c) Consultation With State and Local Agen-
- 19 CIES.—The Administrator of the Pipeline and Hazardous
- 20 Materials Safety Administration and the heads of other
- 21 applicable Federal agencies shall offer to work with State
- 22 and local regulatory authorities to adopt a standard defini-
- 23 tion and methodology for calculating and reporting unac-

- 1 counted-for gas to standardize the data collected by Fed-
- $2\,\,$ eral, State, and local governments.
