HOME INSPECTOR LICENSE

158: 70-9-1. Qualifications and examination applications

Applicants for home inspection license examinations must be eighteen (18) years of age or older and be of good moral character, and every application must be accompanied by evidence of successful completion of ninety (90) credit hours of home inspection training that is approved pursuant to 158:70-9-3, or its equivalent.

158:70-9-2. Examinations

- (a) Home inspection license examinations may include, without limitation, written questions, consisting of open book, closed book and problems, based on current national standards, and other related questions.
- (b) The maximum grade value of each part of the examination shall be 100 points. A passing score is 70% or more on each part.

EXAMINATION

Once Construction Industries Board has received your application, it will be reviewed for approval then your information will be turned over to PSI for testing information.
