 4. No one may use your spot without written permission from management office.
 5. No subletting of parking without written permission from management office.

 7. All variations from the parking must be received in writing and a written permit will be issued from the office, Monday-Friday, 11:30 AM – 4:30 PM.
 8. Failure to meet any of the above mentioned regulations will result in a parking ticket from the Madison Police Department. NO EXCEPTIONS.
 9. Any parking tickets issued will not be rescinded by the management.
 10. There will be a \$25.00 charge for replacement of permit tag.
