

AFFIDAVIT OF NON-USE

PLEASE READ CAREFULLY PRIOR TO COMPLETING FORM

If your vehicle is currently registered and you decide not to operate it, you must either maintain insurance or notify DMV by submitting an AFFIDAVIT OF NON-USE that the liability coverage on the vehicle has been cancelled. Once an Affidavit of Non-Use has been received the vehicle cannot be operated on a California highway until proof of financial responsibility has been submitted and verified by the DMV.

RULES FOR THE ACCEPTANCE OF THE AFFIDAVIT OF NON-USE:

- 1. THE VEHICLE **MUST** BE CURRENTLY REGISTERED: The vehicle must have a valid tag on the license plate. If the vehicle's registration is expired, this form will not be accepted.
- 2. THE AFFIDAVIT OF NON-USE MUST BE **RECEIVED** PRIOR TO THE SUSPENSION DATE: If vehicle's registration is already suspended, this form will not be accepted.
- 3. IF THE VEHICLE'S REGISTRATION EXPIRES WITHIN 75 DAYS, THE SUBMISSION OF THIS FORM, THE AFFIDAVIT OF NON-USE **WILL NOT** BE ACCEPTED. If the vehicle is not being operated, a Planned Non-Operation must be filed.

If you have not received a Notice of Intent to Suspend but want to notify the DMV that the vehicle is not being operated and the insurance has been cancelled, please mail completed form to: **DMV**, **P. O. Box 825391**, **MS D196**, **Sacramento**, **CA 94232-5391**.
