WHY ARE FORMS ADDED?

Agencies typically release new forms based on tax law or compliance changes. When this happens, the ATX tax team analyzes the type of form and the form's usefulness for ATX customers. Based on this analysis, our team decides whether or not the form will be developed and included in the ATX product.

Forms are continuously added to ATX throughout the season. We maintain <u>a forms release schedule</u> on the MyATX Support Center.

WHY ARE FORMS DISCONTINUED?

Federal and state agencies discontinue forms every year, which we subsequently remove from the product. We also remove forms that cannot be filed with an agency because the agency does not accept computer-generated copies. We may also discontinue certain forms that are rarely used by our customers. By removing these forms, we can focus resources on other ATX functionality that provides higher benefits for customers.

Below is a list of discontinued forms for 2013 and their recommended replacements. These forms have been discontinued due to low customer usage or, in the case of some city forms, because a generic city form can be used instead.
