- The service provider will be responsible for any damage to your property caused by the snow removal services covered under this agreement. The service provider will not be held responsible for scrapes, scratches, or other surface damage to driveways, sidewalks walkways, or curbs.

### **INSURANCE**

- Throughout this agreement, the service provider will maintain snow plow insurance under the [STATE/CITY] requirements. This includes general liability, commercial auto, tools and equipment, and workers' compensation.
- The service provider will provide the customer with evidence of insurance before the first service.

#### **PAYMENT**
