MAINTAINING YOUR GOOD STANDING AS AN ACTIVE SIGNING AUTHORITY

- 1. You must remain in good standing with the OSL to continue offering the OSL Air Brake course as an ACTIVE OSL Signing Authority and be promoted on the OSL website.
- 2. OSL Signing Authorities are required to deliver the Air Brake Endorsement course to a minimum of 50 participants per year (*under review)
- 3. OSL Signing Authorities are required to deliver a minimum of one (1) Air Brake Endorsement course per calendar quarter (*under review).
- 4. You must consent to allow OSL to pull a Driver's Abstract every 6 months to confirm driving record is in good standing as required by the MTO Driver Certification program.
- You must not accumulate six (6) or more demerit points on your Driver's License or let your Commercial Driver's License lapse. Any changes to the above must be notified immediately to the OSL writing. You must cease delivering the OSL Air Brake courses immediately.
- 6. You must keep all your participant records for a minimum period of 1 year from course completion date. These records must be kept in a secure environment and be available for inspection by the OSL at any time.
- 7. You must keep your financial account with OSL in good standing. Delay in payments due could affect your active status and impact on courses numbers being issued.
- 8. You must pay upfront the Air Brake program assessment fee of \$825 per year (or less \$100 disc) to maintain your active status.
- 9. You must surrender, upon written request from the OSL, all Air Brake Instructor materials including your laminated test papers, magnetic sign, identity card, and other Air Brake course related materials.
- 10. Selling OSL Air Brake certificates is considered fraud and is not allowed.
- 11. Providing test papers to participants or answers to MTO test papers is not acceptable and not allowed.
- 12. Submitting course results for processing certificates without the participant completing the Air Brake course requirements successfully is considered fraud and is not acceptable.
- 13. All OSL Signing Authorities instructing the Air Brake courses are required to conduct themselves in a professional manner at all times and observe laws of the applicable jurisdiction. In addition, when delivering an OSL Air Brake course, Signing Authorities must adhere to all existing MTO Driver Certification Program policies, all existing and new OSL policies and guidelines. The new guidelines effective July 1st will supersede previous OSL Air Brake program guidelines where applicable.
- 14. The OSL reserves the right to action any violation of the guidelines with the proposed sanctions (see attached Guideline Compliance Sanctions Schedule C) but is not limited to the proposed penalties if further action is required to be undertaken by the Ontario Safety League.
- 15. The OSL reserves the right to revoke your OSL Signing Authority to deliver the Air Brake Endorsement course at any time. You will be notified in writing along with the MTO.
