## APPLICATION FOR ACCOMMODATION

Treaty 7 Urban Indian Housing Authority provides rental units for low to moderate income Native families in Calgary, Cardston, and Lethbridge. Rent is geared to income. Unfortunately, we have a limited number of housing units, and are unable to accommodate all those who are in need of housing. To be considered for accommodations, the following criteria must be met:

- 1. Applicants must be Native.
- 2. Applicant(s) must have dependents under the age of 18 years.
- 3. The Total Gross Household Income must not be over the income ceiling for the location applying for (Calgary, Lethbridge, and Cardston).

Provided you meet all of the above criteria this application form must be completed and include the following required documents (please check off each document that you are including at this time):

_ Income verification from Employer (hours worked per week, total earnings),					
Sponsoring Agent (letter from Band verifying sponsorship), Social Services, etc., for					
EACH member of the household who receives an income from any source					
_ Copy of Native Status Card.					
_ Copy of Alberta Health Care Cards for applicant, spouse/co-applicant and dependants.					
One (1) reference letter from a Previous or Present Landlord.					
_ One (1) reference letter from a Previous/Present Landlord or a Character Reference.					
Letter from your Child Care Worker (if applicable).					

Applicants are placed on our waiting list only when all of the above documents are received, until then your file will remain inactive. Applicants must renew/update their application once every three (3) months. It is very important to inform us of any changes in address, telephone number, family composition, or income in writing. Failure to do so will result in your name being taken off our waiting list.
