




 Requires dealers to transmit vehicle and registration information electronically to the MVA on the same day a 60-day temporary registration plate is issued

Keep records for three years instead of permanently

• Effective October 1, 2010





Timeline for Implementation

 September 30, 2010 – Last day to purchase current cardboard plates

> October 1, 2010 – All dealers to begin issuing new Print-on-Demand Temporary Plate



Early 2011 – Notify Law
 Enforcement that all cardboard
 Temporary Plates are invalid





 - Unable to be titled within 60 days
 - Military
- Unable to obtain a lien release from the lien holder
- Need a duplicate title from another state

Refund Requirements

From October 1st through December 1, 2010, refunds may be requested by submitting the unused cardboard Temporary Plates and the following information to Business Licensing and Consumer Services:

- A request in writing on the dealer's letterhead that includes the dealer's name, address, soundex, dealer number and authorized signature
- A comprehensive listing of the plates being returned
- Total amount of plates returned
- Name of person to contact regarding the refund

Only Temporary Plates purchased within the last year can be returned for a refund
